# Introduction

Welcome to 'Foundations of Anglo-American Law'.

In this course, you will be introduced the core areas of Anglo-American law. Through this process, you will not only be exposed to the workings of another legal family, but you will also learn about the distinctive legal concepts and legal doctrines in the 'common law world' and gain a knowledge of its vocabulary of legal terms.

#### **Overview of Course Content**

The course content is divided between the following substantive parts:

- Fundamentals of Anglo-American Law
- Anglo-American Public Law
- Anglo-American Criminal Law
- Anglo-American Tort Law (Part 1)
- Anglo-American Tort Law (Part 2)
- Anglo-American Property Law

A summary of each part is provided below.

## Fundamentals of Anglo-American Law

'Fundamentals of Anglo-American Law' will introduce you to the workings of the legal system which operates in the Anglo-American world: the common law. We cover the history, legal sources, and legal infrastructure (courts, judges and lawyers). Further, the most peculiar feature of the common law is considered, namely, the doctrine of precedent.

#### Anglo-American Public Law

After introducing the areas of law that make up 'Anglo-American public law', we will study the constitutional law of the United Kingdom and the United States. The goal of these studies is to highlight the differences between German constitutional law and, most particularly, the constitutional law of the United Kingdom.

#### Anglo-American Criminal Law

In 'Anglo-American Criminal Law', after covering some of the basics of this area, we will focus on learning about the legal elements of one crime: murder. After this, our focus will be more procedural. We will specifically look at the role of juries in criminal trials. Over two weeks, we will cover Anglo-American Tort Law. In addition to looking at the fundamentals of tort law, we will study the tort of negligence. The focus is on understanding how the various legal elements of this tort are applied to fact scenarios.

#### Anglo-American Tort Law (Part 1)

'Anglo-American Tort Law' is divided between two parts. In this first part, after giving a working definition of a 'tort' and highlighting the distinction between 'intentional torts' and the 'tort of negligence', we will begin our focus on the intentional torts. We will cover the torts relating to the person and torts concerning property.

#### Anglo-American Tort Law (Part 2)

Given its overwhelming importance in tort law, Part 2 is dedicated to the tort of negligence. After covering its history and noting the concerns that there were regarding the potential for this tort to create indeterminate liability, we will study its various elements. After this study, we can apply the tort of negligence works to some famous tort cases and assess its broader role in society

#### **Anglo-American Property Law**

Lastly, in 'Anglo-American Property Law', you will be introduced to some of the core concepts of property law in the Anglo-American law world. With this knowledge, then we will take a brief foray into 'law of succession' to understand how assets are distributed on someone's death.
